Allison Chance Reported:

- As expected, the PLF for August came in above what was projected (up 27%) due to the State income tax filing deadline being moved to July 15th. September will be more accurate in showing the financial impact of the pandemic.
- If everything remained the exact same through the end of the year, the General Fund could potentially have an ending balance of \$605,000.
- Carolyn Dubiel applied and received the CARES Act Mini-Grant from the State Library of Ohio for \$3,000. The grant will cover the cost of PPE and other related equipment for the Library.

Director's Report: Area Managers' reports included in packet.

Laura Leonard Reported:

- Six staff members from ALIS, Circulation and Pages are returning from furlough this month. Two more staff members will be returning September.
- Due to the impossibility of enforcing social distancing for school aged kids, the Twinsburg Schools superintendent, Kathy Powers, sent a statement from the Library to parents. It read: Due to social distancing and mass gathering orders, the Twinsburg Public Library only has "Browse and Go" services. Students are able to choose materials for checkout, but there is no furniture available for group meetups, projects or long stays. Library staff is available to help with research both in person and through email at librarian@twinsburglibrary.org. These procedures will be in place for the foreseeable future. Library Hours are Mondays, Wednesdays, Fridays, and Saturdays 10:00 am to 6:00 pm and Tuesdays and Thursdays 12:00 pm to 8:00 pm. Vulnerable hours are 11:00 am to 12:00 pm on Tuesdays and Thursdays. - The League of Women Voters will have a voter registration drive in the Library on Tuesdays 11:00
 am to 2:00 pm on August 25th, September 8th, September 22nd, and September 29th.
- Under the CARES Act, all Ohio libraries will receive a \$25,000 grant to help libraries run safely during the COVID-19 public health emergency. This should be used to cover all necessary costs to comply with public health order, local health department recommendations and best practices. We are waiting to hear if previous purchases from earlier this year may be used by this grant as well. This funding is coming through the State's Office of Budget and Management.
- Julia Fisher was asked to teach a Webinar for NEORLS on her experience with creating her online play, *Skyler's Storybook Adventure*.
- Met with Wadsworth Solutions to see about making the air cleaner in the building. They have already increased the amount of fresh air coming into the building by 35%. Fortunately, this has not caused any humidity issues.
